### Verification conditions:

- The detailed results of the verification assessment, carried out on 20.02.2024 - 21.02.2024, are included in the verification assessment report.
- The Verification Statement applies only to the locations, scopes and livestock species submitted for assessment.
- It is not allowed to transfer or use the Verification Statement to third parties.
- TÜV SÜD Polska Sp. z o. o. will be notified immediately about the occurrence of incidents and complaints affecting the welfare of animals by the entity for which this Verification Statement was issued.
- TÜV SÜD Polska Sp. z o. o. may carry out a special unannounced assessment, as a part of the investigation of incidents and / or complaints. The inability to perform such an assessment results in the suspension of the Verification Statement and further the procedure of withdrawal of the Verification Statement.
- Verification reassessment should be carried out before the end of the 12 months period from the date the Verification Statement was issued, or when significant changes occur (eg. animal welfare program revision, additional locations, legal changes, etc.).
- The Verification Statement is only valid with all attachments.
